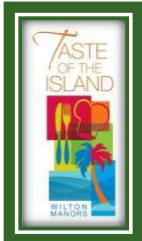

11. **Provide a \$25.00 gift certificate to be used for guest prizes.**
12. Vendors may sell gift cards at the event to guests. **NO OTHER VENDOR SALES OF GOODS OR SERVICES ARE ALLOWED.**
13. A maximum of six (6) staff members will be issued armbands for free admittance at check in.

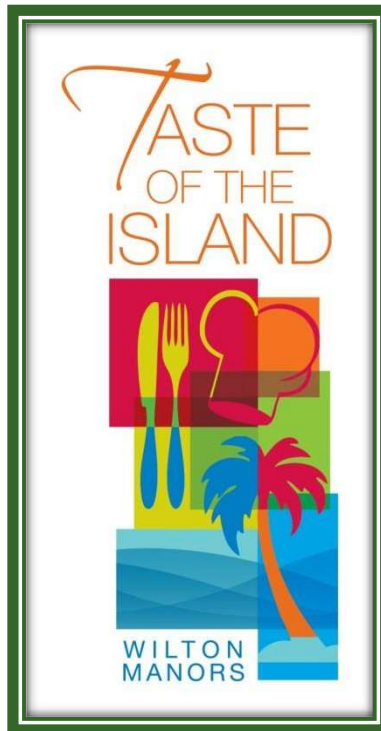
